

KSHA Annual Membership Meeting Minutes

The meeting was called to order at approximately 11:11am by President Diana VanDyke.

Minutes were approved from last meeting. No discussion.

Officers reports:

1st V.P. Denise Meyer:

Spring Fling made \$375 - 26 horses, 10 minis, 2 jump outs - 31 stalls. 108 class entries, 4.15 per horse.

Fall Classic made \$326 - 18 horses, 3 jump outs, 91 class entries regular entry, 22 championship entries, total 113 class entries, 6.27 per horse, 19 stalls - better entry on this event, less horses brought in more money. Championships brought in more money. Another dollar per entry would have brought in a few hundred dollars more. Has four awards she should be bringing, Nancy was going to pick up but couldn't. She will be sure the recipients get them.

Show expenses were asked to be outlined as well. Facility expenses were equivalent taking grants into consideration with Lyons more expensive venue. Overall Fall Classic more profitable. Had \$200 sponsorships, gave \$150 back so it wasn't included in the profits.

It was asked how many KSHA members showed up at those shows: attendance was mostly KSHA members at both shows. Not many KSHA board members at either show; potentially more at the fall show. Interesting.

- V. Board members 22% of our membership must be board members. 48 paid memberships, 68 members including spouses, 15 youth not eligible, so 53 members eligible including spouses. Proposed to add 3 each year instead of 5. Leaving it as is.
- VI. Keep using same venue for the banquet, use local caterers as well, daytime was definitely preferred like we did this year. It was proposed to have the banquet last of February, first of March. It was suggested to have a weather opt-out on the contract with the facility; to rebook a new date with no fees. It was said Arboretum didn't have any other dates available, and we would have lost the grant if the date had been moved. It was mentioned to have a discussed with the venue when booking to already have planned a secondary date in place when booking the primary date.
